Subject : Commissioning of operations of the Solar Plant

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in furtherance to earlier intimations dated 5 November 2022 and 26 October 2023; this is to inform that the installation of the Solar Plant situated at Mantha, Helas, Jalna 431504, Maharashtra has been completed in Phase I with the capacity of 35 MW DC (out of total project capacity of 70 MW DC) and the operations of the Solar Plant have commissioned from 1 July 2024 upon receipt of the commencement certificate issued by 'Maharashtra State Electricity Distribution Company Limited'.

The sum of around ₹138 Crores (net of recoverable taxes) has been incurred till date towards the capital expenditure and the same has been financed through internal accruals. Operations of the Solar Plant will benefit the Company by way of reduction in the power costs.
