## 1. Annual General Meeting

## 2. Final Dividend and Record Date

The Board of Directors at its meeting held on 12 May 2023 has recommended the Final Dividend of ₹ 3 per equity share of ₹ 5 each (i.e. 60 percent) for the financial year 2022–2023 for the approval of the Members at the AGM.

The Record Date has been fixed as <u>Friday, 14 July 2023</u> to ascertain the list of Members entitled to receive the Final Dividend.

Final Dividend, if declared by the Members of the Company at the AGM, will be paid on or before 10 August 2023 through various modes of payment such as direct credit, RTGS, NEFT, NECS, demand drafts, dividend warrants, banker's cheques or any other mode available with the bank, as the case may be, to those Members :

- whose names appear as Beneficial Owners as at the end of the business hours on 14 July 2023 in the list of Beneficial Owners to be furnished by National Securities Depository Limited and Central Depository Services (India) Limited in respect of equity shares held in electronic form and
- whose names appear as Members in the Register of Members of the Company after giving effect to valid applications for permissible transfer of equity shares in physical form lodged with the Company / its Registrar and Share Transfer Agent on or before 14 July 2023.

In terms of provisions of the Income-tax Act, 1961 ("the Act") as amended by the Finance Act, 2020; dividend paid or distributed by a Company on or after 1 April 2020 shall be taxable in the hands of the shareholders. Therefore, the Tax at Source ('TDS') will be deducted at appropriate rates at the time of payment of dividend.

### 3. Voting by electronic means

Pursuant to provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the SEBI LODR Regulations and as amended; the Company is pleased to provide to the Members e-voting facility through National Securities Depository Limited (NSDL) to exercise the right to vote on business items to be considered at the AGM and the business may be transacted through e-voting facility.

The Cut-off date has been fixed as <u>Thursday, 27 July 2023</u> for determining eligibility of Members to vote by remote e-voting or by e-voting at the AGM.

The remote e-voting period commences on <u>Monday, 31 July 2023 at 9:00 a.m. (IST) and</u> ends on Wednesday, 2 August 2023 at 5:00 p.m. (IST).
