Based on intimation received from BSE, the total number of 'Promoter and Promoter Group' are revised to 17 instead of 22 in Table I and Table II by consolidating different folios on the basis of the same PAN. Note No. 2 - As on 31 December 2025, as per the Register of Members, the total number of public shareholders are 22,371. The different folios of public shareholders are consolidated on the basis of the same PAN. As such, the total number of public shareholders appearing in Table I and III are 21,824.
