Based on intimation received from BSE, the total number of 'Promoter and Promoter Group' is revised to 17 instead of 21 in Table I and Table II by consolidating different folios on the basis of the same PAN. Note No. 2 - As on 30 June 2026, as per the Register of Members, the total number of public shareholders are 23,203. The different folios of public shareholders are consolidated on the basis of the same PAN. As such, the total number of public shareholders appearing in Table I and III are 22,702. In view of the aforesaid Note Nos. 1 and 2, as per the Register of Members, the total number of shareholders of the Company is 23,224, instead of the total number of public shareholders appearing in Table I and III are 22,719.
